FEEDING DIRECTIONS

Feed to provide 0.14 mg to 0.42 mg of monensin per pound of body weight. A 150 lb calf must consume 1.4 lb to 4.2 lbs of Calf Starter daily. Provide 2 to 3 gallons of fresh clean water daily in addition to milk or milk replacer. For further information, please contact your Keystone Mills Dairy Consultant.

CAUTION: Do not feed supplemental selenium in excess of 0.3 ppm in the total nutritional diet.

CAUTION: A withdrawal time has not been established for pre-ruminating calves. Do not use in calves to be processed for veal. Do not allow horses or other equines access to formulation containing Monensin. Ingestion of Monensin by equines has been fatal. Monensin medicated cattle feed is safe for use in cattle only. Do not exceed the levels of Monensin recommended by the feeding directions, as reduced average daily gains may result.
