FEEDING DIRECTIONS

Feed Key Heifer 16% Pellet R with good quality forages and/or roughages to meet the nutritional requirements of dairy replacement heifers. Free choice salt may be provided in a mineral feeder. CAUTION: Do not feed supplemental selenium in excess of 0.3 ppm in the total nutritional diet.

CAUTION: A withdrawal time has not been established for pre-ruminating calves. Do not use in calves to be processed for veal. Do not allow horses or other equines access to formulation containing Monensin. Ingestion of Monensin by equines has been fatal. Monensin medicated cattle feed is safe for use in cattle only. Do not exceed the levels of Monensin recommended by the feeding directions, as reduced average daily gains may result.
